### MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

February 17, 2015 – 9:00 A.M. Bonner County Administration Building – First Floor Conference Room 1500 Hwy 2, Sandpoint, ID

On Tuesday, February 17, 2015 the Bonner County Commissioners met for their regularly scheduled meeting with all three Commissioners present. Chairman Kelly called the meeting to order at 9:00 a.m. The Invocation was presented by Noel Koss of the Christ our Redeemer Church, and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Bailey made a motion to approve the Order of the Agenda, as presented. Commissioner Sudick seconded the motion. All in favor. The motion passed.

1) Discussion/Decision Regarding City of Kootenai Law Enforcement Agreement

Commissioner Sudick moved to approve the agreement with the City of Kootenai and Bonner County Sheriff's Office to provide law enforcement services. The City will reimburse the County \$100 per month with the agreement being effective February 17, 2015 and will terminate upon a ninety (90) day notice from either party. Commissioner Bailey seconded the motion. All in favor. The motion passed.

2) Discussion/Decision Regarding Kootenai County Inmate Housing Agreement

Commissioner Bailey moved to approve the agreement with Kootenai County and Bonner County Sheriff's Office to house male and female inmates at the Bonner County Jail facility. Kootenai County will reimburse Bonner County \$60 per day per inmate with the agreement being effective from February 17, 2015 until sixty (60) working days after receipt of a notice of termination. Commissioner Sudick seconded the motion. All in favor. The motion passed.

#### PLANNING - Clare Marley

1) Discussion/Decision Regarding Letter of Support for US Bicycle Route #10 (USBR#10) Through Bonner County (Presented by: Gordon Bates and Clare Marley)

Commissioner Bailey moved to approve the letter of support for the designation of main and alternate routes for U.S. Bike Route #10 through Bonner County and authorize the Board to sign the letter. Commissioner Sudick seconded the motion. All in favor. The motion passed.
