# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

February 24, 2015 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Ste. 338, Sandpoint, ID

On Tuesday, February 24, 2015 the Bonner County Commissioners met for their regularly scheduled meeting with all three Commissioners present. Chairman Kelly called the meeting to order at 9:00 a.m. The Invocation was presented by RT Maldaner of the First Baptist Church, and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Sudick made a motion to approve the Order of the Agenda, as presented. Commissioner Bailey seconded the motion. All in favor. The motion passed.

PUBLIC COMMENT - Ron Kilgore voiced his happiness with the repairs on Gypsy Bay Road, he requested Muskrat Road be maintained and commented that Road & Bridge has done a great job overall.

#### CONSENT AGENDA

Approval of Bonner County Commissioners' Minutes for February 17, 2015

Commissioner Bailey made a motion to approve the Consent Agenda as presented. Commissioner Sudick seconded the motion. All in favor. The motion passed.

## SHERIFF - Daryl Wheeler

Discussion/Decision Regarding Kootenai Tribe Inmate Housing Agreement

Commissioner Sudick moved to approve the Adult Detention Agreement between the Kootenai Tribe of Idaho and Bonner County to house male and female inmates at the Bonner County detention facility. The Tribe will reimburse Bonner County \$60 per day per inmate with the agreement being effective from February 24, 2015 until September 30, 2015. Commissioner Bailey seconded the motion. All in favor. The motion passed.

#### EMS – Bob Bussey

Discussion/Decision Regarding Comdata, Inc. Agreement to Continue Corporate Gas Cards

Commissioner Bailey moved to approve the contract with Comdata, Inc. to continue fuel card services for Bonner County EMS. This is the current company that EMS uses for fleet fuel. Currently EMS has 30 active cards that are used at the pump and allow tracking of mileage for each unit and the driver fueling the vehicle. These cards allow only fuel purchases. I further move to allow the Chairman to sign administratively. Commissioner Sudick seconded the motion. All in favor. The motion passed.

#### ROAD AND BRIDGE - Gordon Bates

Discussion/Decision Regarding Bid Advertisements for Heavy Trucks, Wheel Loader, and Belly 1) Dump Trailer/Gordon Bates

Commissioner Sudick moved to approve the Notices of Advertisement for Road & Bridge for two (2) heavy trucks, one (1) wheel loader and one (1) belly dump trailer.
