Budget Adjustment - Unanticipated Revenues**

WHEREAS, Idaho Code §31-1605 provides that the Board of County Commissioners may adjust the budget as adopted to reflect the receipt of unscheduled revenue, grants, or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes; and


WHEREAS, the Sheriff's Office has received unexpected revenue in the amount of \$3,604.04 from the United States Forest Service for use of the Command Post during the forest fires at Priest Lake; and

WHEREAS, the additional money will be used to add needed radio equipment to the command post vehicle.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby orders the Clerk to schedule revenue in the Justice Fund – Sheriff FY2016 budget, line item# 34-02-737-06 Patrol – Communications Maintenance by \$3,604.04 from \$25,000.00 to \$28,604.04.
