
**WHEREAS**, the Justice Services Department has received unexpected additional revenue in the amount of \$8,922.00 from supervision fees paid by adult offenders placed on supervised probation in Bonner County, Idaho; and

**WHEREAS**, the Justice Services Department requests the additional revenue be placed in the Probation Services FY2017 Budget, line item #0006-01-0699-0000 Adult Misdemeanor Probation Services;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of County Commissioners of Bonner County, Idaho hereby orders the Clerk to schedule revenue in the Probation Services FY2017 budget, line item #0006-01-0699-0000 Adult Misdemeanor Probation Services in the amount of \$8,922.00 from \$15,000.00 to \$23,922.00. This adjustment is due to the receipt of unanticipated revenue received from supervision fees paid by adult offenders placed on Supervised Probation in Bonner County, Idaho.

**Adopted** as a Resolution of the Board of Commissioners of Bonner County, Idaho on the 28<sup>th</sup> day of December, 2016.


