**WHEREAS**, certain expenditure items in the Current Expense budget enumerated in the resolution clause below have been terminated making available said funds for further appropriation; and

**WHEREAS**, it is in the best interest of the County to purchase the property commonly known as 0 Kootenai Cutoff Road in Ponderay for a future EMS Facility.
