SOLID WASTE

Budget Transfer from "A" and "D" budgets to "B" budget

WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

WHEREAS, Solid Waste "A" and "D" budgets have unspent budget authority and,


WHEREAS, the Solid Waste "B" budget has a \$72,000 deficit, and

WHEREAS, the county wants to balance each departmental budget at year-end by reducing said deficits by using the unspent spending authority within that same department;


NOW THEREFORE BE IT RESOLVED that the Board of Commissioners of Bonner County authorize the Clerk to open the Solid Waste "B" and "D" budgets and reduce 0023-00-0405-0000 (Salaries – Employee, Full-Time) by \$40,000 and reduce 0023-00-0413-0000 (Medical Insurance) by \$40,000 and increase 0023-00-0486-0005 (Rural System Collection) by \$80,000 from \$510,943 to 590,943.
