SANDPOINT AIRPORT

Budget Transfer from "D" budget to "C" budget

WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

WHEREAS, the Sandpoint Airport "D" budget has unspent budget authority and,


WHEREAS, the Sandpoint Airport "C" budget has a \$8,289 deficit, and

WHEREAS, the county wants to balance each departmental budget at year-end by reducing said deficits by using the unspent spending authority within that same department;

NOW THEREFORE BE IT RESOLVED that the Board of Commissioners of Bonner County authorize the Clerk to open the Sandpoint Airport "C" and "D" budgets and reduce 0003-05-0413-0000 (Medical Insurance) by \$9,000 from \$19,786 to \$10,786; and increase 0003-05-0803-0000 (Capital Equipment) by \$9,000 from \$5,000 to \$14,000.
