CIVIL LITIGATION

**Budget Transfer from Justice Fund General to  
Justice Fund Civil Litigation**

**WHEREAS**, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

**WHEREAS**, the Justice Fund General Budget "B" budget has unspent budget authority and,


**WHEREAS**, the Justice Fund Civil Litigation "B" budget has a \$112,664 deficit, and

**WHEREAS**, the county wants to balance each departmental budget at year-end by reducing said deficits by using the unspent spending authority within that same department;

**NOW THEREFORE BE IT RESOLVED** that the Board of Commissioners of Bonner County authorize the Clerk to open the Justice Fund General Budget "B" budget and Justice Fund Civil Litigation Budget "B" budgets and reduce 0034-07-0488-0003 (Prof. Services – Dispatch Services) by \$130,000 from \$1,568,540 to \$1,438,540 and increase 0034-11-0480-0015 (Misc. Litigation Expense) by \$130,000 from \$50,000 to \$180,000.
