**Bonner County EMS
Budget Adjustment - Unanticipated Revenues**

WHEREAS, Idaho Code §31-1605 provides that the Board of County Commissioners may adjust the budget as adopted to reflect the receipt of unscheduled revenue, grants, or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes; and

WHEREAS, Bonner County EMS has received unexpected revenue in the amount of \$2,000.00 from the Idaho Community Foundation for the purchase of supplies for the Community Paramedicine program; and

WHEREAS, it would be in the best interests of the EMS department to utilize these funds during the current fiscal year for the suction unit.


NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby authorizes the Clerk to schedule revenue in the FY2017 budget, line item# 99918-9370 Capitol-Other by \$2,000.00 from \$145,460.56 to \$147,460.56.


