

**RESOLUTION NO. 17- 08**

**EMERGENCY MEDICAL SERVICES (EMS)**

**FY2017 BUDGET ADJUSTMENT**

**WHEREAS**, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted to reflect the receipt of unscheduled revenue, grants, or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes; and

**WHEREAS**, Newport Emergency Services is no longer an operating business; and


**WHEREAS**, the EMS FY2017 budget will have unused funds in the amount of \$35,413.00 due to the early termination of the Agreement; and

**WHEREAS**, the EMS department needs a total of \$35,413.00 to cover the expense of a new ambulance and would like to use the \$35,413.00 FY2017 budgeted excess funds stated above.


**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners of Bonner County, Idaho authorizes the Clerk to open the EMS budget to transfer budget authority by decreasing line item 99935-7820, Newport Emergency Services by \$35,413.00  
The Board further authorizes the Clerk to increase the following line items: 99918-9370, Capitol Other by \$35,413.00 from \$80,085.00.00 to \$115,498.00. These funds are to be used to cover the expense of a new ambulance.
