NOW, THEREFORE, BE IT RESOLVED the Board of County Commissioners of Bonner County, Idaho hereby reappoints the following:


Gail Curless to the Bonner County Fair Board for a four-year term beginning on January 20, 2017 and ending January 19, 2021.

The foregoing was duly enacted as a Resolution of the Board of County Commissioners of Bonner County, Idaho, on the 31st day of January, 2017.


